Executive Summary

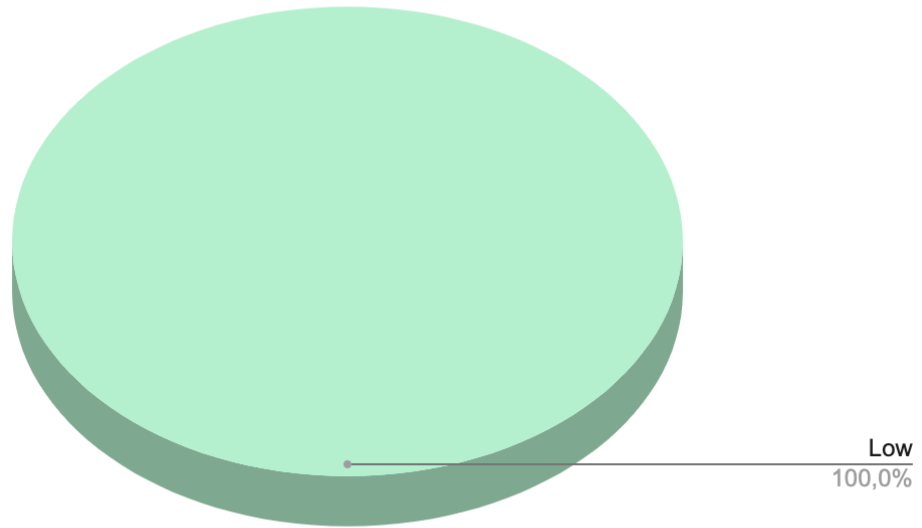
According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 2 low severity issues.

Severity Definitions

Risk Level	Description
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

1. Setting false to mapping value

Instead of setting mapping value to false, it could be more sufficient in gas to delete the mapping key.

Function: removeStakeableContract

Recommendation: Please delete the mapping key instead of setting its value to false.

2. Boolean equality

Boolean constants can be used directly and do not need to be compared to **true** or **false**.

Contracts: TokenVesting.sol

Modifiers: onlyIfVestingScheduleExists,
onlyIfVestingScheduleNotRevoked

Functions: revoke, _computeReleasableAmount

Recommendation: Remove the equality to the boolean constant.



Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **2** low severity issues.
